M.O.ZONE - Seen Around the Strand

On 12/18/11, in the afternoon, Donna Day and Ernie Winn, volunteers, while hiking about 1.25 miles on Jones Grade, observed 3 **Anhingas**, 2 **Double Crested Cormorants**, 2 **Great Blue Herons**, 5 Mature and 2 immature **White Ibis**, and heard **Barred Owls** and a **Red-shouldered Hawk**. They also observed 30 **Zebra Longwings** or **Heliconian butterflies**.

On 12/20/11, around 8:30AM, Tom Trotta, visitor, observed a **Baltimore Oriole** perched high in a Cypress tree around Gate 12/East Main. On 12/29/11, around 3:30PM, Howard Lubel, volunteer, observed a **Bobcat** on JSD about 4 miles north of Gate 12. On 12/29/11 at 8:56AM Tom Trotta saw a **Florida Panther** about 5 miles past the ranger station and at 3:30PM Jim Gibbon photographed one about 10 miles past the ranger station. On 12/31/11, Tom Trotta observed two **Rose Breasted Grosbeak** including 1 adult male on top a Red Maple about 5 miles North of the Fakahatchee Strand Fire Tower.

On 1/4/12, Mike Owen, Biologist, during the Ten-Thousand Island Christmas Bird Count observed 50 least **Sandpipers** along the shoreline of the Faka-Union River as well as observed about 100 **American White Pelicans** flying overhead. On 1/8/12, around 10:15AM, Michael Cullinan, visitor observed a **Florida Black Bear** at a water hole in the Picayune Strand at the end of JSD. He had heard a splash from the water hole and when he turned around he saw an **American Alligator** had gone underwater and the bear running away into Picayune possibly spooking each other!

On 1/14/12, in the early morning, Dave Peters, a Collier Seminole State Park (Canoe Series guide) volunteer, observed his first **Florida Panther** near the end of Janes Scenic Drive (JSD). On 1/14/12, around 11:30AM, visitors also noted a **Florida Panther** on West Main.

On 1/21/12, while having fun volunteering for race day, Dino Barone, FOF Volunteer Coordinator, observed a **Black Racer** and 3 **Great Blue Herons**. On 1/21/12, around 11 AM, Linda Gant, visitor and artist, observed a **Red Bellied Woodpecker** carving out its home in one of the Sabal Palm trees near the Big Cypress Bend Boardwalk area. On 1/21/12 about 11:30AM, Karen Johnson, volunteer assisting on race day, observed a couple of **Red-shouldered Hawks** seemingly guarding Four Stakes Prairie from the edge of a Cypress dome.

On 1/22/2012 at 8:01 am David Sose observed an adult **Bobcat** crossing JSD from west to east, about 20 yards north of gate 15. Upon return at 11.30 AM, he observed a 2 ft long **Banded Water Snake** that was stretched out on JSD about 1 mile north of the Fakahatchee office. On 1/27/12, around 2:30PM, Steven Bass, Park Ranger, observed a young approx. 40 pound **Florida Panther** about 1 mile past Mud tram run right in front of him from North to South on JSD.

Who Was MSD?

Marjory Stoneman Douglas wrote the influential book *The Everglades; River of Grass* and campaigned tirelessly for the environment up to her death at the age of 108 in 1998. She was primarily a writer but in her younger years, she was on the Committee to establish Everglades National Park which was opened in 1947. She became a persuasive speaker when she started Friends of the Everglades in 1968 in an attempt to stop the Jetport in the Big Cypress and later worked with Governor Bob Graham to restore the Kissimmee basin. One of her last efforts was to fight Big Sugar over the condition of Lake Okeechobee. She was given a Presidential Medal of Honor in 1993 by Bill Clinton.

CSO Meeting Report

The 2012 CSO meeting, hosted by the Friends of Florida State Parks and the Florida Park Service, was held in Gainesville on January 5-9. There were many workshops available on the packed days. The following are the ones I attended pertaining most to the FOF.



Donald Forgione, Director of the Florida Park Service, stressed the CSO's are very much appreciated for the 1.2 million hours volunteered for the Parks. The Park Service has a \$85 million budget with \$55 million income. There will be NO PARK CLOSURES! Tourism will lead Florida out of the recession. Donald said that 85 visitors to the Parks create one job for the local economy.

Damon Kirkpatrick returned again this year. He works for the Friends of Georgia State Parks and handles their **Social Media**. Damon's message was "Don't Fight - Join" the Social Media scene. Number 1 users are from 18-34 years old; Number 2 are folks from 55-64, our demographic. He stressed to have social media such as FLICKR, Twitter, Four Square, and You Tube used in the Park while the Visitors are there. Use QR codes; have visitors LIKE us on Facebook. Ask to text a donation in to the Park while they are engrossed there. Get our Visitors engaged on Social Media while they are on site. Use bit.ly to shorten our URL. Use Mad MiMi as a tool to engage our members. Set up and use QR Codes (Quik Response); these are the squiggly squares that you see appearing in ads. Monitor our site to ask visitors questions to keep the dialog fresh on our website. Have FaceBook links to every thing that we publish. Add pictures of Volunteers and participants Thank Volunteers on Facebook. *FOF needs some tech-savvy members to implement our Social Media program.*

One of the FOF major objectives in attending the CSO conference was to get a meeting with Donald Forgione concerning the status of our **Boardwalk Facility Development (BFD)** project. I met for about 45 minutes with Donald, Scott Robinson (Assistant Director), and Valinda Subic (Chief of District 4 and Renee's immediate boss, seen above with the author at the FOF booth).

Although Director Forgione has 160 Parks, he is very aware of the need in the Fakahatchee. The FOF must raise the money for the BFD, but the \$300,000 promised is being used internally to pay for staff design work. Donald also said that he will work to get a Concept Design with cost estimates to the Friends within 30 days! The Interpretation Design will also be expedited.

The results of this meeting are so important for the FOF to go forward. Grant Writing, plans for Fund Raising, all are "on hold" until we have the Concept plan with estimated costs to explain our BFD need to potential grantors and donors.

After this meeting I am confident that the DEP will get us the plans required for the FOF to make the next decision.

HAND FERNS, 2012

Elaine and I went to the Fakahatchee to once again to see and count our old friends the Hand Ferns (*Cheiroglossa palmata*) on January 6 along West Main trail. We counted 21 in a 1000 meter section of the tram. Only 3 had sporangia and only 6 had multiple leaves. The others were one-leaf and droopy. This is the same condition we found in other Hand Ferns along other trams.

As in past years we found poison ivy to be a limiting factor as no ferns were found in Sable Palms that had the ivy in the boots. The life span of individual ferns seems to be 5-6 years in the ones we have monitored. Other factors that play a role in the life of the ferns is Relative Humidity, Light, (refer to past years data), and especially poison ivy.

Counts from previous years:

2005 = 20; 2006 = 17; 2007 = 11

2008 = 19; 2009 = 35; 2010 = 15

2011 = no count; 2012 = 21.

Hope to see you all next January 2013.

BOARDWALK REPORT

January was a beautiful month on the Boardwalk. A large number of visitors got to enjoy the new observation deck at the gator pond. Our resident alligator is usually visible out there, basking in the sun on her favorite log. An anhinga, several ibis, great egrets, and often a black crowned night heron are around nearly everyday. An otter was spotted in the left pond, always a treat for visitors.

It appears that the eagle eggs hatched mid-month and the adults can be seen nearly every day, either sitting on the edge of the nest or bringing in food. We will not know how many eaglets there are until they are big enough to get up on the edge of the nest. The ospreys are also nesting at this time and can often be seen on their very high nest, visible from the Pond Apple marker. Recently an osprey was dive-bombing an eagle that was perched on the 'watching tree', about 50-75 yards south of the eagle nest. Perhaps it was a dispute over food or territory.

Visitors have been fortunate to observe the behavior of alligators in close proximity this year. A mother alligator and her 10 babies are seen nearly every day on or around the dead log that lays across the canal on the right side of the path just before the wooden boardwalk begins. Occasionally the babies can be seen emerging from a hole in the mud-packed bank at the far end of the log. Sometimes the mother stretches out right across the path in the sunlight! It has been three years since either of our females in the gator pond have had young so it's a treat to be able to see the little ones.

We have had several varieties of warblers identified by experienced birders. Karen Relish recently hosted the "Young Birders" out on the boardwalk and they were excited to compile an impressive list, including the Eastern bluebird. We love to see children that are bright, energetic and excited about nature. It bodes well for the environment. May their enthusiasm continue!

Last week Mike Owen, volunteer Linda Koreny, Nelson, and I completed the 2012 Royal Palm Count. We found 96 that could be seen within 50 feet of the boardwalk, our highest number since we began the count in 2004. Although we lost four as a result of the frost in 2010, we have several new ones that are coming along nicely.

The mosquitoes have subsided, the weather is beautiful, so take a day and join us on the boardwalk.
