Mike saw a "first" for him, a **White Crowned Pigeon** actually eating berries on a Dahoon holly (the real Florida holly) near the approach to the Boardwalk on Feb 16<sup>th</sup> at 2:30 in the afternoon.

**American Bitterns** were observed by ranger Steve Houseknecht on Feb 20<sup>th</sup> on the second prairie 1.5miles past the fire tower and by member Bob Czarnecki on Mar 7<sup>th</sup> 12mile north of the first gate.

Visitors from Massachusetts, Grace Peters and Jean Chandler, spotted an **Everglades Mink** on Mar 8<sup>th</sup> between Gates 3 and 7.

Karen and Mike counted at least 10 **Black-Necked Stilts** (with their distinctive long pink legs) at 10:50a.m. on Mar 12<sup>th</sup> in the swamp south of US-41, a mile west of SR-29. Mike had also seen some several days previously.

Mike is looking out for **Ghost Orchids** plants so that he can lead walks in July and August when the mosquitoes are not so prevalent (as the summer rain fills their breeding grounds, fish come in and eat the eggs).

## Letter from John Elting, President of FoF

As your newly elected president, I want first to thank all members and volunteers for their time, effort, and dedication to the Fakahatchee, one of the truly unique places on this planet. I have known the Fakahatchee for almost 40 years and, as the pressures of human encroachment increase unrelentingly, the value of such a place becomes almost incalculable.

We, the Friends, have assumed the responsibility bestowed upon us by Mel Finn. As John Mistletoe said, *To be deeply rooted in a place that has meaning is perhaps the best gift a person can have. If that place has beauty and a feeling of permanence it may suggest to him, unawares, that sense of identity with this physical earth which is the humblest and happiest of life's intuitions.* 

Your new president is a swamp rat. I take great pleasure and satisfaction in leading swamp walks: exposing to any and all the beauty and history of the Fakahatchee, for I believe that education — first hand exposure — and the commitment to explore wild areas is the key to saving them. A heightened awareness can lead to preservation, and preservation in our primary mandate as a Citizens' Support Organization of the Fakahatchee.

Your board is in the process of implementing several changes to take effect during the coming year.

• First, we are switching the date of our <u>annual meeting</u> to coincide with our fiscal year which ends in April. This will make the budgeting process easier and will enable the board of directors to more effectively fulfill their obligations.

• Second, we are implementing additional <u>safety measures</u> for the boardwalk and swamp walks. Radio cell phones and mandatory CPR and first aid training will be added.

• Third, we will be making a concerted effort to <u>increase our volunteer participation</u>. We are calling upon all members to participate as volunteers in a number of areas including guiding, clerical help, events, promotion and, most importantly, exotic plant removal. In early October we will institute a "Volunteer Day" which will consist of a picnic with T-shirts and the opportunity for all members to sign up for forty hours of volunteer work during the months of October through April. We urge everyone in the area to participate in one activity or another. Note: you may call prior to October!

 Fourth, we hope to include notable <u>speakers</u> from other CSO's or environmental groups to address our membership meetings.

Last, we will be updating our web site and newsletter to better convey the schedule of upcoming events.

Financially, we are in good shape as we continue to add new members and receive revenue from swamp walks and the boardwalk. That said, increased contributions are welcomed and necessary as it is our hope to add a new biology/volunteer center in the not so distant future.

Again, thank you all for your continuing support and, please, let's make a concerted effort in the coming year to increase our commitment to the preservation of this magnificent preserve.

## BOARDWALK NEWS

Further to John Elting's letter (see above), Jerry Winters & Signe Backus, Caryl & Nelson Tilden, and Bill Mesce were trained in **CPR and First Aid** by ranger Buddy Griner. We also now have cell phones. **T-shirts** are for sale at the Boardwalk (and at the office) at \$18 including sales tax. The usual adult sizes are available.

We have a **barred owl** that "talks" to us. A visitor with Caryl & Nelson made the usual "who-who" sounds and the owl answered him back several times. The owl (suggestions for a nickname?) always comes to the same roost during the day time so if you're good at hooting, you can try your luck.

Our mother **alligator** is taking good care of her 20 babies (out of about 50 eggs). They are about 10-inches long. She also has 18-inchers from last season around her. The **bald eagles** stay away from the nest but linger on nearby trees so we wonder if their offspring either did not hatch or were attacked.

New volunteers Caryl & Nelson spend several days a week on the Boardwalk and, besides talking to tourists, record bromeliads and orchids for Mike Owen.
