Save the Date! On Saturday, March 19 we will hold the **FOF Annual Membership Meeting** in the park and **Volunteer Appreciation Picnic**. A special bulletin with registration instructions will be sent to the Membership on the last week of February.

Good progress continues with the Boardwalk Expansion – in the first quarter of 2022 the restrooms should be completed, and the parking area should be paved by the third quarter of 2022. We share below an impressive series of aerial pictures of the Boardwalk site. They were taken by Ralph Arwood from an elevation of 3,000 feet.

In December the Fakahatchee was featured in the Naples Daily News twice – first as 'One of Ten Unique State Parks' and later as 'One of Seven Great Wild Spots to Explore'. Shortly after the news articles appeared, ticket sales for the FOF tours increased significantly, providing the funds for the FOF to support the park while we educate the public about the important role of the Fakahatchee Preserve in the Everglades ecosystem.



Views from the Boardwalk

Here are some experiences from November 12 through January 7, mostly at the Big Cypress Bend Boardwalk, plus a few from Janes Scenic, but none made up.

I try to be in attendance at the Boardwalk at least every Friday, with the occasional Monday thrown in for fun. Until recently I was counting 50 guests per day on average, and often 2 of every 10 were from outside the USA. That didn't happen much last season. While the construction isn't real noisy the critter count seems down some. I could certainly understand. We all will like the finished product but getting there is NOT half the fun!

Well, let's get on to what I have seen so far this season. We have a Florida Black Racer that has excited several guests. Nice sized creature. When it is standing still (should that be slithering still?), it hangs over both ends of the boardwalk. FYI, the boardwalk is 6 ft wide. His favorite trick is to act fierce by raising his front 1/3, head cocked, and his neck flattened out -

like a cobra. Now what zoo book did this snake read to imitate a cobra? I guess he could have gone on a school field trip to the library. Anyway, when he does that I chuckle but many a guest draws in a sharp breath.

So far I have only seen one Florida Banded Water Snake, likely a male. I presume the rest are still playing in their big back yard. I'm starting to see more fish in the Strand, along the rock trail area. Earlier there were very few, but now the numbers are way up. Funny how the numbers go up as the water goes down. Sounds like my water utility up north!

Here it makes sense, because the fish can go all kinds of fun places when it's the wet season. Just like us, they like to sample new foods, see new areas, but return home

before it dries up. So you don't have to ask, YES. I have seen some fry Talapia. Remember, you can now legally harvest these African natives. But since they are vegetarians, better try a net or bow/arrow.

I did work (actually more like play) at the boardwalk on 12/24/21. Yup, Christmas Eve day, and you won't believe this. Santa came to the Boardwalk! Honest! He wore a dark green uniform, nicely pressed, a badge, and a red, elf-type hat on his head. He carried a sack, and another elf was with him dressed the same but without the hat. They were jolly but very fit, not plump as the books say. They were smiling and saying Merry Christmas.

OK, turns out they were local Firemen spreading joy and candy canes. I was too far in to see their red sleigh (oops - Firetruck), but they gave me a big handful of candy canes to pass out to other guests. Very nice men, tell them thanks when you see one. It might not be the correct one but they all deserve a thanks! I counted 58 guests that short, 4-hour day.

Well on Sunday, December 26, the Naples Daily News ran a nice article about 5 nature places to visit while here for the holidays. Yes, the Boardwalk was pictured and a nice write up. I contacted Francine, as a heads up, but as always she had already seen the paper. We both agreed that I might mosey down to the boardwalk on Monday, the 27th. *Holy Moly!* I had to run away after 6 hours and 96 guests, with more arriving as I pulled out.

The 96 and I got a Christmas Present from the gator couple in the gator hole at the boardwalk end. A full-on, gator BELLOW! If you have ever been to one you know it will leave a big mark in your long term memory! I saw the lovely Mrs. raise her head, drew in enough air to fill the pouch under her lower jaw, and let 'er RIP. Think of visiting a zoo when the lions are roaring, and the gator has no vocal cords! Like a bullfrog, the air sack makes the noise. Boy does it work well. Within 60 seconds an even lower bellow answered back.

We never viewed Mr. Gator but he wasn't far off. After five minutes, those gators sounded off again. I still haven't seen the male this year. The female is likely 6 to 7ft long while the male is usually twice the female's size – 12 to 13 ft. A very large bull.

Let me explain what I have learned over the years. It will likely be another 2+ months before they mate, and they will let each other know that it's starting to get interesting here in the swamp. The pitch of their sound is such that the water around the gator actually vibrates like it's raining! Approaching the mating season, every other gator within 1/2 mile will also get the same idea.

Well, I ran too long again. I still need to tell you about a LOT of turtle nesting, Mr & Mrs Bald Eagle and their sweet conversations, the Black Crowned Night Herons, our resident Anhinga making multiple dives, our resident Great Blue posing for pictures and dealing with 2 different gators on January 7 – no animals or humans were injured but some guests and this guide got splashed.

Remember, Don't Feed the Wildlife!

On East Main trail near the historic cabin, alligators demonstrating aggressive behavior had to be removed by a licensed contractor paid by Fish And Wildlife Conservation. Such behavior indicates that they have been fed by visitors. Park staff installed a sign to remind visitors it is illegal to feed wildlife.

FOF Board approves 2022 (CSO) Citizen Support Goals.

Park Manager Allen Murray stressed the importance of meaningful Goals to assist the Park, a past example is the Friends 2006 Goal to advocate for our Boardwalk Vision Facilities at the Big Cypress Bend Boardwalk. Currently, there is only a small gravel parking lot, "potties" for restrooms, and little Interpretation along the boardwalk. Yet the boardwalk draws some 80,000 Visitors yearly.

The new facilities of a paved parking area, real restrooms and a Visitors Interpretive Pavilion with "state of the art" interpretative kiosks and graphics will become a major Eco-Tourism destination in Collier County when completed in late 2022.

To fulfill our Goals we need Champions to adopt a Goal, then develop the means and personnel to accomplish the Goal. Is there a specific Goal that interests you? Will you consider taking "ownership" in accomplishing the Goal? Call Francine at 239-695-1023.

Charitable Remainder Trust

On January 1, 2020, the SECURE ACT (Setting Communities Up for Retirement Enhancement) became law. The law had an immediate and direct impact on estate planning for IRA's. The ability for the owner of a traditional IRA to stretch the taxable payments of their IRA over the lives of family members is no longer available. The SECURE ACT mandates that an IRA must be fully distributed by December 31 of the tenth year following the owners death. Attorneys and estate planners have been offering techniques to help their clients deal with this, resulting in the idea of naming a charitable remainder trust (CRT) as the beneficiary of some or all their IRA.

The tax savings of this technique are compelling. As CRTs are considered a qualified charity (just like Friends the Fakahatchee) for tax purposes, any amounts received by a CRT from an IRA are free of tax. This means you can take a tax deferred IRA dollar and have it become a forever tax free dollar and still provide an income to your family. To learn more, it is important to consult your Attorney or CPA to see if this technique makes sense for you.
