President and Executive Director Letter

As it became evident that hurricane IAN's trajectory would impact our area, Park staff turned its attention to following hurricane preparation protocol. The following is an update received yesterday.

Park staff are safe and sound!

With the exception of Jones Grade lakes areas the rest of the Park is closed - re-opening unknown.

Visitor Center still under renovation - no damage, contractor has resumed work.

Pole Barn - still standing!

All residences for Park staff are OK, only minor damages; Other structures in the Park are OK, only minor damages.

Jane's Scenic is flooded - Park staff are busy clearing the debris to facilitate sheet flow.

The old Boardwalk is closed and will remain closed until it is inspected by engineers.

The new Interpretive Pavilion and new restrooms are in good shape. The bridge over the canal and the new Boardwalk are also in good shape. The water was high but there's no evidence it flowed over the new Boardwalk. The crushed shell path at Heron Lake at the end of the new boardwalk washed away and the new parking area flooded, but the water drained well. Note that this is Park staff assessment. The new Boardwalk site is still under DEC contract and DEC will have their own post hurricane inspection.

And what about our members?

It is reasonable to say that the majority of our members are affected one way or another by this hurricane, either personally, family members, friends, or neighbors. We extend our heartfelt wishes for the best possible outcome to all our members who are experiencing hardship during this most difficult time.


