# Naturalist Virginia Palmer-Skok leads the Introduction to Swamp Walks

Ginny credits the majority of her knowledge of the Everglades to Mike Owens, longtime career Park Biologist. She's assisted him for more than three years on research projects and swamp walk interpretation. Projects have included slough surveys of endangered orchids, bromeliads, peperomias, butterfly counts, bird counts, hydrology projects, The Lost Orchid Project, Wildlife Blitzes, and her favorite - Ghost Orchid research. She also serves on the Board of Directors for the Friends of the Fakahatchee.

As a volunteer to the Everglades Foundation, she has supported the Everglades Literacy Program whose goal is to provide education surrounding the Everglades. Ginny also volunteers at the Naples Botanical Garden and Connecticut's Beardsley Zoo Botanical Gardens where she focuses on her beloved orchids.



Her husband, Andy Skok, frequently assists with swamp walks. Both Andy and Ginny have participated in Sea Turtle rescue on Marco Island, support the National Audubon Society Preserve, and lead nature hikes in Connecticut.

# News from the Strand

### New directional signs to the Fakahatchee

The new signs on CC-92 (San Marco Road) at the intersection with US-41 (left), and at the intersection of CC-951 (Collier Boulevard) and US-41 (right), show directions to the Park. *Photos by Tom Maish.* 



Somehow over 120,000 visitors find their way to the Fakahatchee each year despite only one directional sign on US 41. Placing signs along the major highways giving guidance to the Fakahatchee has long been desired. This was one of the Friends' Citizen Support Organization (CSO) Goals in 2022.

Ex-Officio Board member Andrew Tyler and President Tom Maish took on the project. Andrew made computer generated signs showing proposed signs for various locales with the desired language. Andrew's designs were so specific the need for directions to Florida's largest State Park became very apparent.

Tom then researched and contacted the Officials at F.D.O.T. who had jurisdiction for proposed signage along the area roads. That research lead to Troy Norwood, Professional Traffic Operations Engineer (PTOE), District 1, who then directed us to Dan Hall, PTOE with Collier County for signs under Collier County jurisdiction. Dan Hall was very familiar with the Fakahatchee having often visited the Park.

As a result of Dan Hall's work, signs are now in place at the intersection of CC-951 (Collier Boulevard) and US-41. The signs on CC-92 (San Marco Road) at the intersection with US-41 give directions for visitors coming from Marco Island. Neither intersection had signs to the Fakahatchee previously.

The Friends understand signs provided by F.D.O.T. are being fabricated for installation. Stay tuned for the sequel to this major project assisting visitors in locating the Fakahatchee from all directions.

# **Donation Strategies by Chris Gair**

A sigh of relief...

I'm going to roll up my sleeves a bit here as it relates to the SECURE *(Setting Communities Up for Retirement Enhancement)* ACT and what followed that had a few folks concerned. The "ACT" became law on January 1, 2020 as a major piece of legislation impacting retirement planning.

I've discussed some of the details in previous issues so I won't reiterate those here. As with any piece of tax law from Congress, the IRS responds with Proposed Regulations. The ACT was no exception as the IRS published sixty-four pages of their famous fine print outlining "suggestions" as to just how the ACT should be enforced.

Thankfully, the technique of designating a charitable remainder trust (CRT) as a beneficiary of an IRA was not part of the proposal. I've written previously on this technique that I believe is one of the great "win-win" opportunities in charitable planning so I won't belabor it here. However, in a nutshell, it's a way to capture 100% of your IRA with no income tax while serving family members as well.

So, if you have (or will have) an IRA and would like to help the Friends in your estate plan, please talk with your attorney to learn more. Thanks again for your support of this treasured resource!
