Dear Mr. Currey:

The Fahkahatchee project was presented to the Board of Governors of the Nature Conservancy on the agenda of the annual meeting held at New London, Connecticut, on August 23-26, 1963. A favorable resolution, depending on a satisfactory funding proposal, resulted.

We feel that we should strive to purchase the entire area outlined on your map under an agreement which would permit steady progress, without undue risk of forfeiture, toward final ownership.

May I suggest a 23 year \$1,000,000.00 deal for the 66 3/4 sections described on your map, computed at a price of \$15,000.00 per section to be paid for in 22 consecutive annual installments each of \$45,000.00 covering three sections, with the 23rd and last payment of \$10,000.00 to apply to the remaining 3/4 section, it being understood that upon each payment of \$45,000.00 a three-section block shall be released in progressive stages until the plan for acquisition has been completed.

This plan of purchase would fit our limited financial capabilities provide a sound basis for us to work toward our goal.

Your consideration of this proposal would be appreciated.
